Registration confirmation and details regarding vendor check-in will be provided to the Vendor at the email address provided above within three (3) business days upon payment verification and registration acceptance. Registration forms with insufficient payment will be rejected. Registration and payment shall be deemed the Vendor's total commitment to the event. No Refunds; No Exceptions.

Please note the guidelines during the event:

1. The vendor mentioned above agrees to render the vendor fee described above, according to the terms set forth.
Please note your spot is not secured until both deposit and contract are returned completed and signed.
2. The vendor agrees to conduct themselves professionally, courteously, and ethically without regard to race, religion, national origin, sex, gender, sexual preference, age, disability, veteran status, or political affiliation.
3. Vendors do not have to stay the entire event but are strongly encouraged.

Equipment/Posts/Set-Up: A vendor briefing meeting will take place TBD to communicate how goods and services will be sold and how to interact with customers.
